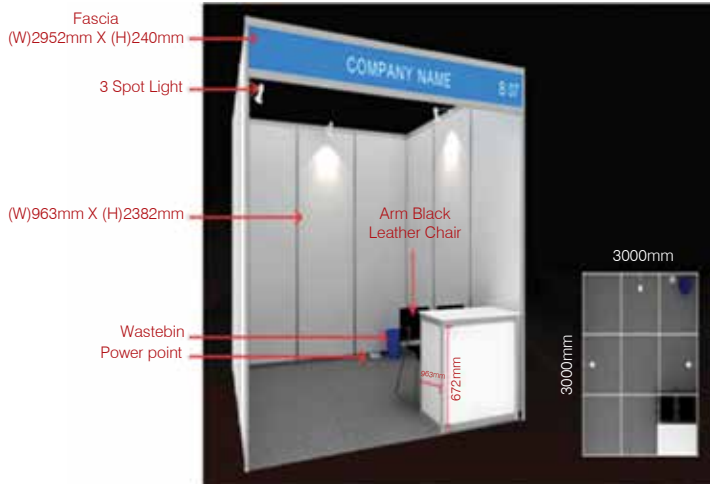
Open Sides Charges

Corner Stand	2 open sides	5% of space charges
End of Block	3 open sides	7.5% of space charges
Island site	4 open sides	10% of space charges
Premium Location	Marked in the floor plan	15% of space charges
Mezzanine Floor	-	25% of space charges

Shell Stand Specification

Booths are provided in cubicles of a pre-fabricated system (Octonom), made of aluminium hardware profiles & laminated ply partitions with standard accessories

Specifications of basic elements provided in standard 9 sqm Shell Scheme Booth

- Synthetic needle punched carpet (inside the stand area)
- White laminated wooden system partitions of 2.5mts height. (max. 3 sides)
- Fascia board, 0.3mts height with 10cms height company name in white sticker
- 1 Table (Prefabricated System)
- 2 Chairs (Folding / PVC type)
- 1 Waste bin
- 3 nos. 100w Spotlights
- 1 Socket point – 5 / 15Amps (with 1KW power supply per 9sqm)

- No modifications in stand space allowed for stands of 18 sqm and below".

2. Raw Space Specifications

Charges includes: space rental, stand cleaning & catalogue entry.

Only the floor space is provided to the dimension of the booked stand. Exhibitors are responsible for the design, construction, furniture and electrical installation of the stand using contractors of their own choice, within the rules & regulations of the contract. Electrical connection will be provided upon request, and consumption will be charged extra.

Stand construction details will be given in the Exhibitor manual.

C Payment Terms:

Stage 1: Registration Fee:
50% of Space charges including (Open side, Mezzanine charges & Sponsorship charges if any) + Service Tax (ST applicable to Indian Companies/Exhibitors only) required along with Application and Contract Form.

Stage 2: Deadline: 3 month prior to the show
Balance 50% Space charges payment including (Open sides, Mezzanine charges & Sponsorship charges.

D Registration and Confirmation

Application for acceptance as an Exhibitor at the event must be made by submitting the completed and signed application form along with proof of payment.

Acceptance of the application will be confirmed in writing by UBM India Pvt. Ltd.

E Acceptance

Whether an application will be accepted depends on a number of factors, including space availability. In case of over subscription of space, applicants will be placed on a waiting list and will be notified accordingly. Applicants on the waiting list will be prioritized according to the dates of the applications. Allocation of booth location will be at the discretion of the Organizer.

F Cancellation

Once the Contract has been concluded and the Contract is cancelled up until 180 days prior to the start of the Exhibition, the Exhibitor shall be liable to pay 50% of the Monies. If the Contract is cancelled during the period of 180 and 120 calendar days prior to the start of the Exhibition, 75% of the Monies are payable by the Exhibitor. If the Contract is cancelled within 120 days prior to the start of the Exhibition, the Monies are payable in full by the Exhibitor.

As per Tax Applicable
